PROCESSING OF PERSONAL DATA POLICY

pursuant to art. 13 of Law no. 171 of 21 December 2018 and UE Regulation 2016/679 of 27 April 2016 (GDPR)

The **Fondazione Renata Tebaldi**, with registered office at Via Oddone Scarito 84, 47893, Borgo Maggiore, RSM, San Marino VAT number (COE) SM20118 (hereinafter referred to as the “Controller”), in its capacity as Data Controller, is hereby informing you, pursuant to art. 13 of the EU Regulation 2016/679 (hereinafter referred to as the “GDPR”), that the data provided by you as the competitor will be processed in the following way and for the following purposes:

1. DATA SUBJECT TO THE PROCESSING:

1.1 The identifying personal data (e.g. name, surname, date of birth, nationality, address, telephone number, e-mail address, bank and payment details) – hereinafter referred to as “personal data” or also just “data” – you communicated to the Controller as part of the registration for the Renata Tebaldi International Voice Competition will be processed.

2. PURPOSE OF THE PROCESSING

Pursuant to art. 6 of the EU Regulation 2016/679, your data will be processed exclusively for the correct and complete development of the event with the following purposes:

- To fulfil tax and accounting obligations;
- To be communicated to employees, consultants or companies that may be involved in the development of the event;
- To be shared with media outlets interested in publishing information concerning the event;
- To comply with the mandatory obligations of the Controller and provided for by applicable laws.

3. PROCESSING METHODS AND DATA RETENTION

3.1 The processing of your personal data will be carried out through the operations described in art. 4 of the Privacy Code and art. 4 no. 2) of the GDPR, namely: collection, recording, organisation, storage, consultation, processing, alteration, selection, retrieval, alignment, use, combination, blocking, disclosure, erasure and destruction. Your personal data will be processed in both paper and electronic and/or automated forms.

3.2 The Controller will process your personal data for the time necessary to fulfil the purposes set out in art. 2 and in any case for no more than 10 years from the date of the event, also

with regard to personal data acquired for marketing purposes. At the end of this period, the data will be deleted or anonymised.

4. ACCESS TO PERSONAL DATA

Your data may be made accessible for the purposes set out in art. 2:

- To the employees and collaborators of the Controller in their capacity as people in charge of the processing, internal data protection officers, and/or system administrators;
- To third parties or other entities (e.g. credit institutions, professional firms, consultants, insurance companies, etc.) who perform outsourced activities on behalf of the Controller, in their capacity as external data processors;

5. DISCLOSURE OF PERSONAL DATA

5.1 Your data may be disclosed for the purposes set out in art. 2 to supervisory bodies, judicial authorities, insurance companies for the provision of insurance services, as well as to those entities to whom the disclosure is mandatory by law for the accomplishment of the aforementioned purposes. Such entities will process the data in their capacity as Independent Controllers.

5.2 Your data will not be disclosed.

6. TRANSFER OF PERSONAL DATA

Your personal data will be stored on servers located in the Republic of San Marino. The possible transfer of data inside the European Union will take place without any prior authorization based on the provisions set out in art. 46 of Law 171/2018. It is understood that the Controller, if necessary, will have the right to move the servers also outside the EU. In such a case, the Controller ensures that the transfer of the data outside the EU will be carried out in accordance with applicable legal provisions, after agreeing on the standard contractual clauses provided for by the European Commission.

7. NATURE OF DATA PROVISION AND CONSEQUENCES OF THE REFUSAL TO PROVIDE THEM

The provision of data for the purposes set out in art. 2 is mandatory. If not provided, we will not be able to guarantee the completion of your registration for the event.

8. RIGHTS OF DATA SUBJECTS

8.1 In your capacity as Data Subject, you enjoy the rights set out in art. 15 of the GDPR.
